This is in reference to your application for correction of your naval record pursuant to the provisions of title 10 of the United States Code, section 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 17 September 2002. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your naval record and applicable statutes, regulations and policies. In addition, the Board considered the advisory opinion furnished by NPC memorandum 1160 Ser 811/319 of 8 August 2002, a copy of which is attached.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice. In this connection, the Board substantially concurred with the comments contained in the advisory opinion. Accordingly, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.

1. In response to reference (a), recommend disapproval of the petitioner's request.

a. The petitioner reenlisted on 02 January 2001 for four years and received a zone "C" SRB entitlement for the GSM(0000) rate. The petitioner received 47 months of the zone "C" SRB entitlement.

b. The petitioner requests to adjustment to maximize the total SRB amount.

c. The petitioner's ADSD is 13 December 1988. On the date of reenlistment the petitioner's total active service was 12 years and 19 days. Per reference (b), the SRB zone "C" window is from 10 to 14 years and pay out to the 16 active year. The reenlistment carried the member one month beyond 16 years. The petitioner received the maximum amount allowed for the zone "C" reenlistment.

2. In view of the above, recommend the member's record remain as is.
